Statutory Consultation proposing to establish a new non-denominational Primary School and Nursery Classes at Granton Waterfront and implement Catchment Changes

I am writing to let you know that a statutory consultation on the above proposal commences today Thursday 22 August 2024 and will run until Thursday 3 October 2024.

The statutory consultation paper proposes the establishment of a new non-denominational primary school and nursery in the Granton Waterfront Development area in the north of Edinburgh.

It also proposes changes that affect the catchment boundary of Craigoyston Primary School, Granton Primary School and Pirniehall Primary School. The new primary school would feed to Craigoyston Community High School and changes are proposed to the catchment boundaries of Broughton High School and Craigoyston Community High School.

If the proposal is approved by the Council, a new school will be constructed on the new site after a period of stakeholder engagement and design. The new school would open in August 2028 at the earliest. There would be no mandatory transfer for pupils already attending another school.

A detailed summary of the proposals is provided in the attached document including maps illustrating the new site location and changes to catchments.

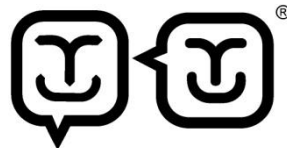
