A Welcoming Place	2019 Strengths	Weaknesses / Recommendations
Welcoming	Large park with a good linear path offering good travel links for walking/cycling. Signage at relevant access points. Good views across and beyond at either end.	No orientation map or distance indicators.
Good Safe Access	Good entrances and wide tarmac path with lighting offering easy access from one end to the other with other paths allowing access / exit from surrounding streets. Clearly contributing to the wider travel network. Good crossing point in the middle. Bus links and access from surrounding neighbourhoods.	A very wide path which could easily offer a dividing line to separate cyclists and walkers. Cyclists going at speed especially on down hill sections appear silently and from almost nowhere. Grass paths weren't that obvious. One entrance is blocked off by a tree trunk to prevent unauthorised access but appearance doesn't suggest a welcoming feel.
Signage	Threshold signage and notice boards announce the park well. Way markers offering some directional information. Clear signage indicating a cycling/walking route and wider cycle network.	Lack of clear map and boundary showing entrance/exit points. No phone number seen in the notice boards or on signage.
Equal Access	Good wide path with seating available at good intervals. Dropped kerbs at most entrances.	Although the paths remove some severe gradients, there is still an element of steepness. May have been an option to level some parts out further and provide steeper shortcuts for more abled cyclists / walkers (desire lines may indicate need for this).

Appropriate Provision of Faciliti	Good paths and seating, Notice boards offering some information	Distances on the way markers would have been useful as well as a clear map in the notice boards. The feeling of the park is one of a through route or a place to walk a dog. Consider how to make the park more of a destination. Potential to maximise the views and offer more interpretation at points.
Safe Equipment & Facilities	Nothing stood out as unsafe. Crossing points etc all designed well.	Cyclist / pedestrian separation line could be provided.
Personal Security in Park	7 The path is lit and sightlines are good in places.	Better way markers could be provided, A few area that were isolated. Evidence of drinking at a bench on a side path with lots of empty cans suggest a hangout.
Dog Fouling	Some signage.	More signage on lamp posts perhaps. Instances found on the path. No bins on site as yet.
Clean & Well Maintained		
Litter & Waste Management	Fairly clean with only the odd bit of litter here and there with the exception of one specific area.	One heavily littered (empty beer cans) area though at the seat near the north east side of the park. No bins on site.
Grounds Maintenance	6 Site is still maturing.	Management strips along path edges could maintained better although appreciate that these areas appear to be establishing following path works. Grass paths are not that well maintained.
Tree Maintenance	8 Lots of new trees (mixed species) planted as well as some more established woodland areas.	Couple of failed trees.
Building & Infrastructure Maint	8 Path in excellent condition, minor paths are okay.	
Equipment Maintenance	6 Bins, seating and signage mostly in good condition.	Some graffiti on signage towards Craigmillar side.

Some information about the timetable of future developments of the park and how to get involved i.e. starting a FG. No contact phone number.
Educ. & Interpretative Provision	A little interpretation about bees and how to get involved.	Consider maximising the view points, potential of viewing areas or interpretation of specific areas along the way.
